Course Overview

It enables managers to better understand the capabilities of their teams, identify underutilised opportunities, ensure compliance with commercial legislation and regulatory obligations, and provide effective operational oversight.

This programme ensures leaders can confidently manage digital investigators while maintaining legal compliance, evidential integrity, client confidence, and operational resilience.

Who is the course for?

This course is designed for commercial professionals with responsibility for supervising or managing digital investigation staff, including:

- Managing legal obligations, client expectations, and operational decisions
- Debrief and Strategic Review
- Structured discussion around leadership decisions, governance, and operational effectiveness
